Wages: The volunteer understands the services provided will be a donation and under no circumstances will expect wages, salary, or benefits from the organization for the services provided within this volunteer agreement.

Supervision: The Volunteer should report to **Samantha Carter, Val Carter or Michael Carter** on each day services are provided for instruction and guidance.

Employment: The Volunteer understands they are under no terms considered an employee of the Organization. Furthermore, the Organization acknowledges the Volunteer is not an employee and may provide services at free will. The Volunteer will receive no employee benefits including disability, pay, workman comp, or severance pay.

Liability: The Volunteer agrees to indemnify and hold the Organization harmless against any damages related to the Volunteer's activity. Additionally, the Organization shall hold the Volunteer harmless against any damages related to the Volunteer's service.

The Volunteer agrees that they are a competent adult and experienced rider and/or horse handler. I, and I alone, am responsible for my own safety. I the undersigned, for myself, hereby release, discharge, and covenant not to sue any directors, officers, principles, agents, members, volunteers, property owners and other riders from any and all claims and liability, including but not limited to negligent acts and omissions, for any and all property damage and personal injury to myself and all minor children in my care arising out of any and all direct and indirect participation in activities operated, hosted, sponsored, including but not limited to all events and activities related in any way to **Green Valley Stables, LLC**. This release, discharge, and covenant not to sue is intended to include, though not limited to, any and all claims for negligent acts or omissions in the provision of tack, equipment, or equines to myself, in the determination of any rider's ability to safely engage in equine activities or handle a particular equine, and the use of any land or facilities for the above-described activities.

VOLUNTEER AGREEMENT

I, on behalf of myself, understand and assume the risk that both designated and non-designated riding areas may have varying terrain that may be hazardous; that terrain may be altered or become hazardous due to weather, wildlife, domestic animals, act of God or acts of humans beyond the control of any person or entity released from liability herein; that equine activities can be hazardous and have inherent risks.

Per Missouri Law 537.325.1

WARNING

Under Missouri law, an equine activity sponsor, an equine professional, a livestock activity sponsor, a livestock OWNER, a livestock facility, a livestock auction market, or any employee thereof is not liable for an injury to or the death of a participant in equine or livestock activities resulting from the inherent risks of equine or livestock activities pursuant to the Revised Statutes of Missouri.

Jurisdiction: Any and all legal proceedings that may arise from this volunteer agreement shall remain in the jurisdiction of Missouri. The Volunteer agrees that in the instance of legal proceedings they will cooperate with the Organization as well as the Organization's agents. The Volunteer agrees to provide written notification to the Organization in the event that an incident takes place while the Volunteer is providing services.

Termination: Because the Volunteer is not an active employee, they may terminate this volunteer agreement at any time for any reason they deem necessary. The Organization may decline to accept the Volunteers time and may terminate this agreement without prior notification.
